

Driver Education and Driver Behind-the-Wheel Training Certificates

New Policy

Provisional instruction permits are not valid until the instruction permit is signed by a licensed or authorized driving instructor **or** the applicant reaches the age 17 ½. Effective immediately, applicants applying for a provisional instruction permit are required to submit a completion certificate for driver education but are **not** required to provide proof of enrollment in behind-the-wheel training.

New/Revised Certificates

Revised and/or new Driver Education and Driver Behind-the-Wheel Training (DE/DT) certificates have been created.

The new/revised certificates will have a two digit alpha code that when scanned or keyed will collect the following information:

- Identify the certificate as enrollment or completion.
- School type, such as: public, private, home school/private school satellite program, or DMV licensed school.
- Classroom, non-classroom, or integrated driver education and driver training course.

The Department of Motor Vehicles will continue to accept existing revisions of DE/DT certificates issued prior to September 1, 2010.

The Certificate of Enrollment in Behind-the-Wheel Training, Public/Private Secondary School, (DL 392) and Certificate of Enrollment in Behind-the-Wheel Training, DMV Licensed Driving School (OL 392) are now **obsolete**.

Please make sure to order the revised/new certificates in time to have them before September 1, 2010. The new/revised DE/DT certificates may be ordered using a standardized order form. The order form should be available by June 15, 2010 at <http://www.dmv.ca.gov/vehindustry/ol/forms/supplyorderforms.htm>. Courier service will deliver all orders. An individual must be present to receive and sign for the shipment. Allow 4 – 6 weeks to process an order.

If the address on the order differs from the one that Occupational Licensing has on file the order will not be filled. Contact your local inspector for assistance with your address change.
